





14	Brief Description of the Assignment:	<p>Bangladesh National Museum has undertaken a program under the title “Decorating and Displaying Gallery and Development of Library at Andarmahal of Ahsan Manzil for”. Part of the project has been implemented during fiscal year 2014-2015. Remaining major components of the program are as follows :</p> <ul style="list-style-type: none">(i) Buildings and structures for display and exhibition including wall and roof, doors and partition, grills, paintings, fitting and fixtures including show case, props and modern exhibition lights, fans and electrical works including cabling, and very essentially Diorama, Semi diorama, Oil painting, Ornamental Almirah, Ornamental Table & Ornamental Chair etc. (Details will be explained by the undersigned)(ii) Room air cooling system including air-curtain.(iii) Electrical Equipment and gadgets (Cabling, LED Lights, Fan, Switches and optical fiber connection of Internet connectivity) as necessary for the project.(iv) Procurement and Installation of Closed Circuit TV Camera (CCTV) for capturing and preserving video image for security purpose, on turn-key basis.(v) Fire Extinguisher & Fire Alarm System (Incl. sprinkler in appropriate case).
15	Submission of EOI:	<p>This is a composite job. Only truly capable firms and companies (or, group of firms/companies) having essential competence and with significant experience of working for a museum are hereby called upon to express their interest (EOI) on organizational letterhead for doing the job on quality in time. Expression of Interest (EOI) letter, addressed to the undersigned, together with required documents, duly signed and authenticated, shall be submitted in sealed envelope and delivered to the address of the undersigned by 10 January 2016. The envelope must be clearly marked “Expression of Interest Notice for Ahsan Manzil Andermahal”. Intending firms/companies must be able to engage capable consultants, professionals and expert workers for the job, with proven track record of quality art and masonry work with sensibility of working for a delicate place like museum. All works must be done 30 April 2016.</p>
16	Other Important issues:	<ul style="list-style-type: none">(i) Given the complex nature of the job (variety of tasks), a firm/company may league up with up to two other firms/companies (e.g. JVCA) etc. for attaining necessary collective capability, as provided in Public Procurement Act/Rules. In case of sister concerns, proof of single ownership must be submitted, in addition.(ii) Should any clarification be required, the undersigned may be contacted till 12 noon of 06 January

	2016 during the office hours. (iii) Failure to submit any of the required document may disqualify the firm/companies for the job
17	Experience, Resources and Delivery capacity Required: Pursuant to Public Procurement Act/Rules of the country in force, only short listed firms/companies responding to the EOI notice will be requested to submit proposal (RFP) for the job. The client, Bangladesh National Museum, shall not be responsible for any cost or expense that may be incurred by the firms/companies for preparing or delivering the EOI with document. The client reserves the right to accept or reject any proposal without assigning any reason thereto. Interested Firm/Organizations are advised to contact the undersigned for visiting Ahsan Manzil Museum and inspecting the location of works (if necessary to explore the scope of the assignment).
18	Documents : Documents to be submitted with the letter to express interest are: (a) Trade license renewed for current fiscal year, (b) Company certificate of incorporation in case of a company, (c) National ID card of the CEO/MD, (d) Business identification number (VAT number), (e) Taxpayer identification number :TIN, (f) Income tax certificate for the assessment year 2015-2016, (g) Experience of working for one museum in last three years. (Of an amount of not less than BDT 1 crore) (h) Proof of turnover of at least 3 times of the quoted amount for the works mentioned above in last 3 years, (i) Bank liquidity /Bank credit facility/Working capital certificate as much as the quoted amount, at the minimum. It is underscored that copies off all documents to be submitted must be duly authenticated by a senior officer of the government. Failure to submit any of the above document or obvious inadequacy may disqualify the firm/companies for the job.
