




Expression of Interest Notice
Modernization of Bhattashli Exhibition Gallery
Bangladesh National Museum, Shahbagh, Dhaka-1000

Bangladesh National Museum intends to modernize its Nalinikanta Bhattashli Exhibition Gallery situated in its Shahbagh complex and has received some funds from the Government of Bangladesh for the purpose. Built in 1983, the gallery needs complete renovation and refurbishment. Also, existing facilities must be improved while modern display facilities may be added that will attract artists and event organizers and impress visitors. Addition of digital technology and automation are desirable. Capable firms and companies having necessary capabilities and relevant experiences are hereby requested to express their Interest on firm/company letterhead for doing the job on quality in time. Expression of Interest letter, addressed to the undersigned, duly signed and accompanied with required documents shall be submitted in sealed envelope and delivered to the address of the undersigned by 23 March 2015. The envelope must clearly marked "Expression of Interest for Modernization of Bhattashli Exhibition Gallery".

Pursuant to Public Procurement Act in force, only the short-listed firms/companies will be requested to submit proposals. The client, Bangladesh National Museum, shall not be responsible for any costs or expenses that may be incurred by the firms/companies in for preparing or delivering of the EOI. Bangladesh National Museum reserves the right to accept or reject any proposal without assigning any reason. Documents to be submitted together with the Expression of Interest letter are: (1) Trade License, (2) Company certificate of incorporation in case of a company, (3) National ID card of the MD/CEO of the firm/Company, (4) Business Identification Number certificate, (3) Taxpayer Identification Number (e-TIN), (4) Income Tax Certificate for the assessment year 2014-15, (5) Certificate of experience of successful completion of a similar job of a value of BDT 1 crore in one work-order, (6) Certificate of turnover of BDT 2 crore in last 5 years, (7) Bank solvency certificate of an amount of BDT 1 crore, (8) CV of an architect with experience of minimum 5 years who will work for the project, (9) CV of a graphic designer who will work for the project, (10) CV of an electric engineer who will work for the project and (11) Copies of all documents submitted with EOI letter must be attested by First Class gazetted officer of the Government of Bangladesh. Failure to submit any of the above documents will disqualify the firm/company.

Given the complex nature of the job, a firm/company may league up with upto firms/companies for enhancing capabilities. Should any clarification be required, the undersigned may be contacted till 12 noon of 22 March 2015.
