



Expression of Interest Notice (Eoi)
Modernization of Main Lobby (Entry Hall)
Bangladesh National Museum, Shahbagh, Dhaka-1000


Bangladesh National Museum (BNM) intends to modernize and improve Main Lobby (Entry Hall) of the main building situated in its Shahbagh complex and has received some funds from the Government of Bangladesh for the purpose. Built in 1983, the Entry Hall of the building needs complete renovation and refurbishment. Also, existing facilities must be improved while modern display and lighting facilities and utilities for the visitors should be added. Apart from beautification, there is ample opportunity to install modern gadgets and equipment. Addition of digital technology and automated processes are desirable.

Therefore, competent firms and companies having necessary capabilities, knowledge of modern gadgets, and relevant experiences in museum works and interior decoration are hereby requested to express their Interest on firm/company letterhead for doing the job on quality in time. A letter of Expression of Interest, addressed to the undersigned, duly signed and accompanied with required documents shall be submitted in a sealed envelope and delivered to the address of the undersigned by 24 March 2015. The envelope must clearly be marked "Expression of Interest for Modernization of Main Lobby (Entry Hall)". Pursuant to Public Procurement Act and Rules in force, only the short-listed firms/companies will be requested to submit technical and financial proposals. The procuring entity, Bangladesh National Museum, shall not be responsible for any costs or expenses that may be incurred by the firms/companies for preparing or delivering of the Eoi. Bangladesh National Museum reserves the right to accept or reject any proposal without assigning any reason thereto.

Documents to be submitted together with the letter of Expression of Interest are: (a) Trade License, (b) Company certificate of incorporation (only in case of a company), (c) National ID card of the MD/CEO/Proprietor of the firm/Company, (d) Business Identification Number certificate, (e) Taxpayer Identification Number (e-TIN), (f) Income Tax Certificate for the assessment year 2014-15, (g) Certificate of experience of successful completion of a similar job of a value of BDT 50 Lakh in one work-order in last 3 years, (h) Certificate of turnover of BDT 2 crore in last 5 years, (i) Bank solvency certificate of an amount of BDT 50 Lakh, (j) CV of an architect with similar experience of minimum 5 years, (k) CV of a graphic designer with similar experience of minimum 5 years, (l) CV of an electric engineer with similar experience of minimum 5 years and (m) CV of an IT expert with versatile experience of minimum 5 years.

Given the complex nature of the job, a firm/company may league up with upto two firms/companies for enhancing collective capabilities. In such a case, the lead firm/company shall submit the letter of Eoi while documents (a) to (f) of the partner firms/companies, not over two, must be submitted without fail. Copies of all documents submitted with Eoi letter must be attested by a First Class gazetted officer of the government of Bangladesh. A list of documents is warranted. Failure to submit any of the above documents may disqualify the firm/company altogether. Eois will be evaluated based on basic competence as a business entity, nature and extent of proven track record and existing capabilities. So other relevant documents may also be submitted accordingly.

Should any clarification be required, the undersigned may be contacted till 12 noon of 23 March 2015. Inspection of the Main Lobby is encouraged prior to submission of Eoi. Please contact the undersigned for an appointment for visiting BNM and inspecting the Lobby.
